## The Constitution of the Governing Body:

In terms of the provision of the apex body and affiliating body, an institute shall have a Governing body to administer the affairs of the college, which shall have the following composition.

### **Composition:**

- The Governing Body (BoG) shall have at least eleven members including the Chairman and the Member Secretary. The Trust shall nominate six members including the Chairman and the Member Secretary, and the remaining five members shall be nominated as indicated below.
- Chairman to be nominated by the Trust. The Chairman of the BoG shall preferably be a technical person either Entrepreneur or an Industrialist or an Educationist and has demonstrated an interest in promotion of the quality Education.
- Five Members (Industrialist/ Technologist/ Educationist) to be nominated by the Trust.
- Nominee of the Government of Bihar (Ex-officio)
- Principal /Director of the concerned institute (as nominated by the Trust)- Member Secretary.
- Nominee of the University
- Two Faculty members to be nominated from amongst the regular staff.

### **Guidelines for appointments of trust nominees:**

The persons, whose names are included by the trust, in the panel for nomination on the Governing Body should be those whose contribution in the field of education is significant.

### **Tenure:**

Nominated member, other than ex-officio member, shall hold office for a term of five years. However, he can be re-nominated, subject to the condition that no member can continue for more than three terms.
